<p>Surrender</p>	<p>At any point of time during the policy term, the policyholder can opt to surrender the policy subject to the terms mentioned below:</p> <p>Policy Surrendered during the Lock-in Period: The fund value net of Policy Discontinuance Charges shall be credited to the Discontinued Policy Fund.</p> <p>Policy Surrendered after completion of Lock-in Period: The policy stands terminated and fund value as on date of surrender must be utilized by policyholder in the same manner as vesting benefit.</p>
